



WEBSITE PRIVACY POLICY

This page describes how our website is managed with regard to the processing of personal data of users who consult and interact with it. This policy also constitutes privacy policy provided pursuant to Articles 13 and 14 of EU Regulation no. 2016/679 (“**GDPR**”).

This policy is provided only for the laborplast.net website (the “**Site**”), and not for any other third-party websites that may be accessible to you through links posted thereon.

DATA PROCESSING “**CONTROLLER**”

The data controller is LABORPLAST S.p.A., with registered office at Via F. Magellano 52, 20020, Magnago (MI) and operational headquarters at Via Massari Marzoli 21, 21052, Busto Arsizio (VA), Fiscal Code and VAT Number 01710340157 (the “**Controller**” or “**LABORPLAST**”).

CATEGORIES OF PROCESSED DATA

Navigation data

The computer systems and computer programs used to operate the Site acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes the IP addresses or domain names of the computers used by users who connect to the Site, the addresses in URI (*Uniform Resource Identifier*) notation of the resources requested, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user’s operating system and computer environment. Navigation data will be collected exclusively in the legitimate interest of allowing the user to enjoy the content published on Controller’s Site and its proper administration and management. These data are stored for a short time and could be used to ascertain responsibility in case of potential computer crimes against LABORPLAST. Thereafter, the data are kept only in anonymous form for statistical interest only.

Data voluntarily provided by the user

PROCESSING MODALITIES AND SUBJECTS AUTHORIZED TO PROCESSING

The processing related to the web services of this Site (physically placed in “hosting” at the Europe-located server WIX.com inc.) takes place at Controller’s headquarters. Information control and custody are taken care of by authorized personnel assigned to the reception of online requests. The data may occasionally be accessed, for technical reasons only, by authorized personnel providing support to the Site and Controller’s computer systems. No data from web browsing is communicated or disclosed to further third parties except in compliance with legal obligations. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

DATA TRANSFER ABROAD

Requests and messages spontaneously sent to the Controller towards email addresses or in filling out web forms on the Site as well as navigation data may be tracked/stored on servers located outside the EU or the European Economic Area (EEA) belonging to the third-party platforms we use; consequently, if your personal data might be transferred to entities or companies located outside the EU or the European Economic Area (EEA). In these cases, or in case of necessity to use other types of non-EU providers who have access to some of your personal data, the Controller will provide you with full information and ensure that every measure (contractual and non-contractual) appropriate and necessary is taken to ensure an adequate level of protection of your personal data in accordance with and in the manner specified by Chapter V of the GDPR and, in any case, by the current legislation on the protection of personal data. In any case, you may always request more information about the identity of non-EU third parties who may know/process Your personal data and the activities performed by them by making a request to the Controller at privacy@laborplast.net.

DATA SUBJECTS RIGHTS

As data subject, you have the right to ask the Controller for access to, rectification, deletion of data, restriction of processing or to object to the processing of data under the conditions set out in Articles 15,16,17,18,21 of the GDPR. Finally, the data subject has the right to lodge a complaint with a Supervisory Authority if he or she believes that the processing concerning him or her violates the legislation applicable to the protection of his or her data.
