









PRIVACY POLICY PURSUANT TO EU REGULATION NO. 2016/679

Dear User, we wish to inform you that EU Regulation no. 2016/679 ("GDPR") provides for the protection of individuals with respect to the processing of personal data. Therefore, LABORPLAST S.p.A., as the "Controller", in accordance with Article 13 of the GDPR, provides you with the following information regarding the processing of your personal data collected through the "Contact Us" forms on the website www.laborplast.net.

- A. **CATEGORIES OF DATA**: We will process only your personal data released in the fields of the "Contact Us" section at www.laborplast.net. We will also process information voluntarily rendered in the free-fill field. In this regard, please do not release information of a sensitive nature or information about third parties or, of course, statements that are harmful to the decorum or dignity of others. Please note that, according to current legislation, children under the age of 14 should not give online services any information or personal data without the consent of those exercising parental responsibility over them. Should LABORPLAST become aware that personal information has been provided by a person under the age of 14, LABORPLAST will immediately delete the message and the data contained therein.
- B. **COMPULSORINESS OR NOT TO PROVIDE DATA**: Failure to provide data in the fields with optional completion as well as partial or incorrect data provision, may result in the inability to fully or correctly process your requests.
- C. **SOURCE OF PERSONAL DATA**: Personal data are collected directly from you when you submit this form.
- D. **PURPOSE OF DATA PROCESSING AND LEGAL BASIS:** The processing of your personal data in connection with the completion of these forms has as its legal basis the need to fulfill pre-contractual requests of the data subject (Article 6, par. 1, lett. b), of the GDPR) as well as the legitimate interest of the Controller in fulfilling requests for information solicited by the data subject (Article 6, par. 1, lett. f), of the GDPR).
- E. **DATA RECIPIENTS:** To the extent pertinent to the stated purposes, your data will be processed by individuals authorized to process and manage corporate communications. For exclusive reasons of technical support to Controller's website or IT system, the data may be accessible to IT personnel authorized to do so. The hosting service providers/applications/IT platforms hosting this site and the resulting communications are responsible for the technical storage of the data and are identified as data processors under Article 28 of the GDPR. Your data will not be disseminated in any way.
- F. **DATA TRANSFER ABROAD:** Your personal data will be processed by the Controller within the territory of the European Union. Should it become necessary for technical and/or operational issues to use entities located outside the European Union, or should it become necessary to transfer some of the collected data to technical systems and services managed in the *cloud* and located outside the European Union, the Controller will provide full information and verify that every measure (contractual and non-contractual) appropriate and necessary to ensure an adequate level of protection of personal data is taken in accordance with and in the modalities indicated by Chapter V of the GDPR and, in any case, by the current legislation on the protection of personal data. In any case, You may always request more information about the identity of the non-EU third parties who may know/process your personal

- G. **DATA PROCESSING MODALITIES:** The personal data you provide will be processed by computer tools in compliance with appropriate technical and organizational security measures suitable to prevent data loss, illegal or incorrect use and unauthorized access.
- H. **STORAGE PERIOD:** The data collected will be stored for the time strictly necessary to fulfill your request and to keep track of it in case of any developments, after which it may be deleted.
- I. **DATA SUBJECT RIGHTS:** Pursuant to Chapter III of the GDPR, the data subject always has the right to request from the Controller access to his/her data, rectification or erasure of data, restriction of processing or the possibility to object to processing, to request data portability, to withdraw (where requested) consent to processing by asserting these and other rights under the GDPR by simple communication to the Controller. Finally, the data subject has the right to lodge a complaint with a Supervisory Authority if he or she believes that the processing concerning him or her violates the legislation applicable to the protection of his or her data.
